## **ORDINANCE NO. 1815**

AN ORDINANCE OF THE CITY OF SIDNEY, NEBRASKA TO AMEND SECTION 1042.21 WATER SERVICE RATES, CHAPTER 1042 WATER OF TITLE FOUR UTILITIES, OF PART 10 STREETS, UTILITIES AND PUBLIC SERVICES CODE OF THE CODIFIED ORDINANCES OF THE CITY OF SIDNEY, 1977, TO PROVIDE FOR A DIFFERENT MONTHLY BASE CHARGE FOR YEARLY USAGE OF WATER, TO REPEAL ANY OTHER ORDINANCE OR PART OF ORDINANCE IN CONFLICT WITH THE PROVISIONS THEREWITH, AND TO PROVIDE FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF SIDNEY, NEBRASKA:

<u>Section One.</u> That Chapter 1042 Water, Section 1042.21 Water Service Rates of the Codified Ordinances is amended to read as follows:

## SECTION 1042.21 WATER SERVICE RATES

Effective no sooner than March 1, 2020 the following water service rates shall be applicable to all customers, either within or outside of the corporate limits of the City, connected to the municipal water system on a monthly billing basis.

## WATER USAGE RATE SCHEDULE
